<u>Preferred Approach: Housing Background Paper</u> <u>Supply for Gedling Borough Council</u> (<u>December 2022</u>)

The Greater Nottingham Strategic Plan Preferred Approach document sets out the housing supply for Gedling Borough Council as shown on the housing trajectory at Appendix B. The housing trajectory sets out the number of dwellings anticipated to be completed each year of the plan period for each source of supply.

The context for the housing provision and distribution in the Greater Nottingham Strategic Plan is set out in the Preferred Approach: Housing Background Paper (December 2022). Housing trajectories are also included as Appendix A of the Housing Background Paper.

This document provides a list of sites that make up the housing supply within Gedling Borough Council for the Greater Nottingham Strategic Plan Preferred Approach. The list of sites comprises separate tables which reflect the first six sources of supply as shown in the housing trajectory, as follows:-

- 1. Non-allocated sites and identified SHLAA capacity (474 dwellings) these are sites not allocated in the Local Plan and identified in the SHLAA. They include sites that:-
 - are currently under construction;
 - have planning permission;
 - are the subject of a planning application with a resolution to grant permission subject to s106 agreement;
 - are the subject of a planning application pending a decision on an existing site that has or had planning history; or
 - have planning permission for communal accommodation.
- 2. Teal Close (579 dwellings) an existing strategic site rolled forward from the Aligned Core Strategy (adopted September 2014).
- 3. Gedling Colliery/Chase Farm (625 dwellings) an existing strategic location rolled forward from the Aligned Core Strategy (adopted September 2014) and allocated for housing in the Local Planning Document (adopted July 2018).
- 4. North of Papplewick Lane (83 dwellings) an existing strategic site rolled forward from the Aligned Core Strategy (adopted September 2014).
- 5. Top Wighay Farm (1,445 dwellings) an existing strategic site rolled forward from the Aligned Core Strategy (adopted September 2014) plus an extended area proposed for allocation for 640 dwellings in the emerging Greater Nottingham Strategic Plan.
- 6. Local Plan Part 2 sites (2,433 dwellings) these are existing sites allocated in the Local Planning Document (adopted July 2018).

The seventh source of supply as shown in the housing trajectory is windfall (1,677 dwellings). The windfall allowance is based on the number of dwellings built on non-allocated sites over the previous 10-year period. The windfall allowance contributes to housing supply from Year 4 (i.e. 2025/26) to avoid double counting with existing planning permissions.

To reflect the approach taken in the preparation of the Greater Nottingham Strategic Plan, the status of sites listed in this document is correct as at 31 March 2022. Any updates to sites since 1 April 2022 (such as work starting on site, the site being fully built out, a new planning permission being granted or a new planning application being submitted) are not included in this document.

The approach taken to the housing supply for the Greater Nottingham Strategic Plan differs from the Gedling Borough Strategic Housing Land Availability Assessment (SHLAA) reports published in December 2022 as the SHLAA reports contain updated information (post 31 March 2022) that supersedes information included in this document. The SHLAA reports are available at the Council's web page https://www.gedling.gov.uk/shlaa.

This document also notes whether each site that makes up the housing supply comprises brownfield land (previously developed land). While it is not uncommon for new housing development to be developed in residential gardens within built up areas, making efficient use of land, it should be noted that development in these locations are recorded as greenfield in accordance with the definition in the National Planning Policy Framework (2021) which reads as follows:-

"Land which is or was occupied by a permanent structure, including the curtilage of the developed land (although it should not be assumed that the whole of the curtilage should be developed) and any associated fixed surface infrastructure. This excludes: land that is or was last occupied by agricultural or forestry buildings; land that has been developed for minerals extraction or waste disposal by landfill, where provision for restoration has been made through development management procedures; land in built-up areas such as residential gardens, parks, recreation grounds and allotments; and land that was previously developed but where the remains of the permanent structure or fixed surface structure have blended into the landscape."
